Repetition is most likely a common theme for me in this issue of the Lines. I am quite certain that I usually mention how hard it is to believe we are past the halfway point of our enjoyable Summer season – but as you may agree – it is hard to imagine! It seems like just yesterday we were struggling out of the starting blocks with some less than desirable Spring weather. I can tell you since mid-May when the weather straightened out, it has been all systems go on every front. Hopefully our coming months can produce the same type of activity levels with one change in the weather department – a little more nighttime precipitation.

On June 20th, Lake Arrowhead hosted Barkin' For Birdies, a first time event that benefited the South Wood County Humane Society. Never knowing how a first-time fundraiser will go, we were all extremely pleased with the 108 player turnout that helped yield nearly \$13,000 in funds for the Humane Society. It was not only appreciated, but it was gratifying to see so many of our Lake Arrowhead members participate. So nice to see a group that understands the purpose of a fundraiser, actually supporting the event for all of the right reasons.

On July 19th we continued a longstanding tradition of hosting our largest golf/food and beverage event of the year – the Wisconsin Cheese Makers Association Golf Outing and Trap Shoot. This year's total number of participants, sponsors and WCMA approached eight hundred. When we began hosting this event in 2000, the outing was contained to our two courses but it has grown significantly to now encompass five area courses and the Wisconsin Trapshooting facility with the day's activities concluding here at our clubhouse for social hour and dinner. My hat is off to all of the Lake Arrowhead staff involved in administering a group and event of this magnitude. Thank you all for an awesome performance!

As we announced in May, we are getting closer to engaging in a necessary pool project with the work commencing the first week of September following the closing of the pool. This is all part of the continual effort to update and

improve the amenities as they require attention. In addition to the Fall pool project we are in the midst of evaluating and assessing other projects that may need to be on the horizon. The North Lake floating piers, the stairway to the North Lake Marina and the Chalet pool are amenities that are in the discussion. I am confident the Common Area Committee will be compiling their prioritized list to submit to the Board this Fall prior to the budgeting time frame. I bring this topic up as I find it is important to let everyone know we are committed to improvements which will most likely be a never-ending task given the size of our development and all of the offerings.

I am hopeful that the second half of the season will be as productive as the first. Please continue to enjoy Lake Arrowhead and all it has to offer.

Common Areas Committee News

Amenities

The primary mission for the Common Areas Committee is to preserve, enhance, and evaluate the existing amenities and assess the need for additional amenities. The committee meets on the third Friday of each month from April to October. Our goals are to determine repair or replacement on each amenity and to gather information on costs, substitutes, timelines, and resources to secure the best choices to forward to the Lake Arrowhead Board of Directors and Lake Arrowhead Management team. Our committee is dedicated to protecting our community and keep it looking beautiful and manageable for years to come.

Report

Each Common Areas Committee member was assigned an amenity to inspect and to document needs in order of importance or condition. Common areas reviewed were:

- Chalet
- Campground and Sports Field
- South Lake Center and Marina
- West Lake Center
- North Lake Center
- Mid Lake Center
- Clubhouse

Those members assigned to each of the common areas gave detailed reports with recommendations. The buildings are solid and well maintained by Steve and his crew. Other than minor cosmetic updates such as painting, repairing of rotted trim, or maintenance of plumbing and electrical, the overall conditions are very well kept. We are looking at the cracks in the tiles in the bathrooms of the lake and campground buildings and we will gather information for either repair or replacement as needed. One of the concerns were

the urinals in the men's bathroom at North Lake. Due to the high iron content in the well water, the porcelain tends to stain rather quickly and tends to look unkempt. Our maintenance supervisor, Steve, and his crew will continue their vigilance in trying to stay ahead of the staining.

The committee reviewed the South Lake Center Pavilion ceiling due to the mold growth and discoloration of the tongue and groove boards. Many ideas and presented options for repair and replacement were offered and the committee determined to remove the ceiling boards and leave it open to the rafters to give the appearance of a larger interior atmosphere similar to the North Lake pavilion. Steve will determine if additional lights or fans will need to be installed. The overall look will be improved with less maintenance needed over the coming years due to weathering of the existing boards.

Lastly, the committee submitted a Cost Sharing Assistance Request for Shoreline Protection for the West Lake Center to the Adams County Land and Water Conservation Department. We are eligible for a 50% cost share. This will be brought for a 2024-2025 budget item.

In closing, please be safe and enjoy the amenities provided by the Lake Arrowhead Association. Respect the common areas and lake so we might provide an enjoyable environment for generations to come.

What is causing the fish to die in our Lakes?

The short answer: Columnaris.

According to Jennifer Bergman of the Wisconsin DNR, Columnaris is a common and widespread bacterial disease of freshwater fish caused by the bacteria *Flavobacterium columnare*, which can cause yellow-brown or white lesions on the skin, fins and gills of fish. Columnaris outbreaks are a normal occurrence, especially in late spring and early summer when the water is warming up. Outbreaks and the intensity of outbreaks varies from year to year depending on the timing and intensity of the spring warm-up. The columnaris bacteria does not infect humans or other animals.

Fish species that the DNR has seen die from Columnaris in Adams County waters include bluegills, pumpkinseeds, crappies, bass, catfish and bullheads. Die-offs are selective and don't wipe out populations, these fish kills are typically not significant. Lake Camelot, Lake Arrowhead, and Jordan Lake all had reported dead fish within the same week. These dead fish were reported after the hot weather we had with a quick warm-up. Bacteria bloom + aggregated fish stressed from spawning = Columnaris outbreak and fish kill.

It is doubtful the alum treatment caused any mortality to fish in Lake Sherwood or downstream Lake Arrowhead. The pH was

monitored during application, and there was only minor variation, which would not cause a pH shock to fish.

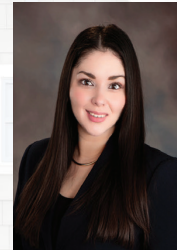

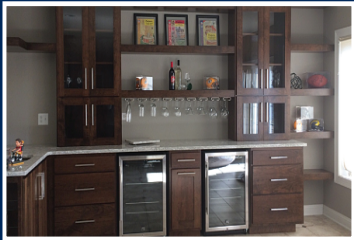

Lake Arrowhead Things to Know

This is a summary of restrictions only. A full copy of the **DECLARATION OF RESTRICTIONS, COVENANTS AND EASEMENTS** can be found at ["lakearrowheadgolf.com/about/links"](http://lakearrowheadgolf.com/about/links) scroll down to download.

The restrictions, covenants and easements are imposed to promote the quality of life of the community by establishing standards for development.

V. RESTRICTIONS

1. No outside toilet or privy may be erected in the Community, except by the Developer.
2. No person may introduce any diseased or noxious plant, animal or insect.
3. No activity which interferes with the privacy of any other person.
4. No noxious, offensive, or illegal activities shall be tolerated on any tract.
5. No business can be run on any residential parcel.
6. No mobile home may be placed on any tract other than on mobile home lots.
7. No camping, except on lots designated for that purpose.
8. The only furniture allowed outside of buildings is lawn furniture.
9. Removal of trees and vegetation are restricted. Clear cutting must be approved with building plans.
10. Building techniques must guard against erosion.
11. Once construction begins, it must be completed in three months on mobile homes and nine months on residential lots.
12. No occupation until water and sewer are completed.
13. No stripped, partially wrecked, or junked motor vehicle, trailer, boat, refrigerator, stove/other appliances, or any other salvage item of any kind shall be permitted.
14. Fuel storage tanks must be buried or screened by fencing or shrubbery.
15. Clotheslines shall be placed so they are out of view. NOT allowed in EASTBRIAR.
16. All tracts shall be well-maintained.
18. Any damaged structure must be rebuilt or repaired as quickly as possible.
19. Only one mobile home allowed on a mobile home lot and must be 500 sq. ft.: a minimum length of twenty-two (22) feet and one (1) accessory building.
20. All structures must conform to local building codes.
21. Setbacks for buildings are 35 feet from FRONT LOT LINE (100 feet for Spotted Fawn), 10 feet from SIDE LOT LINES & 25 feet from REAR LOT LINES.
22. No parcel or lot shall be divided or re-divided, except as is otherwise specifically provided in the declaration.
23. Nothing may be done on any residential lot, which alters the surface drainage patterns in such a way as to be detrimental to any other tract in the Community.
24. SEE RESTRICTIONS FOR COMMERCIAL LOTS.
25. The committee MAY ESTABLISH RULES AND REGULATIONS governing the burning of trash, rubbish, grass, brush and other materials anywhere in the Community.
26. Only ONE single family in a dwelling lot.
27. Dwelling must have a minimum of 760 sq. ft. Fairway, Waterfront or Restricted lots must be 1000 sq. ft., 1400 sq. ft. in EASTBRIAR.
- 29(a). All associated structures shall be built of NEW MATERIALS. Place of USED structures shall be prohibited.
- 29(b). No animals other than normal pets such as cats & dogs- two each is the MAXIMUM.
- 29(c). NO SIGNS. (Including, but not limited to, "For Sale", "For Rent", or similar signs) billboards or other advertising structure of any kind may be erected or maintained anywhere in the Community.
- 29(e). No trees over six (6) inches in diameter shall be removed, except as necessary for construction.
- 29(j). "Subdued Natural Tones" which is compatible with the usual esthetics of the surrounding natural environment. "The Committee shall be the final judge of what constitutes "subdued Natural Tones".
 1. Any construction work on any residential lot, with the cost of at least \$100.00 REQUIRES approval of the committee.
- 29(i). Complete plans for any proposed associated structure or other construction work is required.
